

# Rising Brook Rugeley Flood Alleviation Scheme

October 2017

## Background

The Rising Brook rises in Hednesford before flowing through Cannock Chase and into Rugeley. The Brook is culverted in Rugeley before entering the River Trent to the east of the town centre.

Flooding from the Brook occurs when the culvert is full. This leads to water flowing over the top and through the playing fields. Water may also back up and flow through the town. Surface water can't drain into the culvert and backs up on highways.

Historical records show flooding occurred in 1845, 1950s 1960s and 1980s. Flooding in 2012 was thought to be solely due to intensity of rainfall.

## Reducing flood risk

The Environment Agency has been constructing a flood storage area on Hagley playing fields which will store flood water from Rising Brook and then slowly release it back into the brook. The main feature of this flood defence is an embankment, 380 metres long and 4 metres high.

During the construction period Hagley playing fields will remain closed.

## How will this work help?

- The scheme will alleviate flooding to 114 residential properties and 159 commercial properties.
- The reduced risk of flooding will enable sites in the town centre to be redeveloped. For example we have received enquiries for a site on Power Station Road to be redeveloped which we can now approve.
- The project does not address surface water flooding directly, but reducing the flow through the culvert will help surface water drain off.

Future redevelopment of the town centre may provide opportunities for additional works on the culvert in the town centre to improve drainage further and allow for better surface run off.

## Progress

The bridge construction is largely complete, with just the surfacing remaining. These works have been carried out with close collaboration and co-operation with the district Council to ensure it is in keeping with the Heritage. The bridge was previously supported by

some very large rocks which we have reused within the design. The bridge will allow the public to access the heritage trail adjacent to the Mill Leat.

The rising brook is now flowing through its natural path, which is a key milestone for the project.

The sheet piling is now complete. We appreciate it was noisy and disruptive so we would like to thank you for your patience while we were doing this.

## Works Programme

- January 2017 - Construction Commenced
- October / November 2017 – Grass Seeding
- December 2017 - Completion
- Late 2018 - Playing field reopened to the public.

Please note the football fields will not be available for use as they need time to 'bed in', this takes approximately two years.

## What's happening next?

Once the construction of the embankment is complete it will be ready for top soiling and grass seeding.

Construction will be complete by the end of December although the Hagley playing field will be closed for a further 12 months to allow the grass time to establish, as the grass plays an important role in the stability of the embankment.

## Fantastic community support
